Good Morning,

One of the takeaways from the 8/18/2016 meeting between CMS and the NCPDP Prescriber Task group, was for NCPDP to provide detailed examples of the proposed file layout and associated claims processing scenarios. This request has been accommodated within the attached document. Please note, this is very similar to the document submitted on March 30, 2016. Minor changes were made to clearly define the requested new attributes and claim processing rules. The file layout section portrays what the Medicare Individual Provider Enrollment file would look like based on each Post date and the second table depicts how this information would be integrated into a PBM claims processing system.

The status of historical records post any changes to the file layout is still under review by the Task Group. Please refer to the "Concerns with Historical Records" section of this document for an overview of the specific use cases. This is the primary agenda item for today's task group call.
